Talking Circle Background



Talking Circles

Talking Circles or Circle Talks are a foundational approach to First Nations pedagogy-in-action since they provide a model for an educational activity that encourages dialogue, respect, the cocreation of learning content, and social discourse. The nuance of subtle energy created from using this respectful approach to talking with others provides a sense of communion and interconnectedness that is not often present in the common methods of communicating in the classroom. When everyone has their turn to speak, when all voices are heard in a respectful and attentive way, the learning atmosphere becomes a rich source of information, identity, and interaction.

Talking Circles originated with First Nations leaders - the process was used to ensure that all leaders in the tribal council were heard, and that those who were speaking were not interrupted. Usually the Chief would initiate the conversation, with other members responding and sharing their perceptions and opinions of the topic under discussion. The process provides an excellent model for interaction within the learning environment as well. It is also very adaptive to any circle of people who need to discuss topics and make decisions together.

Use Outcomes to Drive Decision-Making

Principle: Assessment and evaluation of important educational outcomes must drive accountability and decision-making for investment in innovation.

- Step 1 Establish more robust, reliable, and consistent ways of evaluating innovation "success".
- Step 2 Develop processes for ensuring novel, evidence-based methods are implemented in educational programs that holds innovation programs accountable.

Ensure Alignment on Michigan Medicine HSEI Activities with Strategic Goals

Principle: A shared understanding of HSEI activities and goals will ensure internal innovation investments align with Michigan Medicine Education strategic goals, which are informed by specific domains of focus.

- Step 1 Provide coordination of institutional innovation funding that (1)
 balances the degree of change with institutional priorities and HSEI goals, (2)
 allows for both smaller seed-funding for creative, proof-of-concept projects
 and large-scale investments.
- Step 2 Align selection and implementation of ideas and allocation of resources for innovation with the domains of focus.


